SOFTWARE LICENSE AGREEMENT FOR BUD-E READING APPLICATION

PLEASE READ THIS SOFTWARE LICENSE AGREEMENT ("LICENSE") CAREFULLY BEFORE USING THE BUD-E READING SOFTWARE. BY USING THE BUD-E READING SOFTWARE, YOU ARE AGREEING TO BE BOUND BY THE TERMS OF THIS LICENSE. IF YOU DO NOT AGREE TO THE TERMS OF THIS LICENSE, DO NOT INSTALL AND/OR USE THE SOFTWARE.

1. General.

A. B. Bud-e, at its discretion, may make available future upgrades or updates to the Bud-e Software for your compatible iOS or Android device. The terms of this License will govern any new software or software upgrades or updates provided by Bud-e, unless such upgrade or update is accompanied by a separate license in which case you agree that the terms of that license will govern such upgrade or update.

2. Permitted License Uses and Restrictions.

A. License. Subject to the terms and conditions of this License, unless you obtained the Bud-e Software as described in Section 2B, you are granted a limited, non-transferable, non-exclusive license to install and use the Bud-e Software on any compatible iOS and Android device that you own or control. You may not distribute or make the Bud-e Software available over a network where it could be used by multiple devices at the same time. You may not rent, lease, lend, sell, redistribute or sublicense the Bud-e Software.

B. Volume or Education License. If you obtained the Bud-e Software under a volume or education license program with Bud-e, the terms of your volume or education license will determine the number of copies of the Bud-e Software you are permitted to download, install, use and run on iOS and Android devices you own or control.
